**\*\*NEW\*\* Letter to the Editor Template: Election Administration Legislation URGENT**

### Background:

Following up on the Action Alert sent the morning of June 2, we urge local Leagues to write a letter to the editor of their local newspaper on the election administration legislation being considered by the Ohio General Assembly. This legislation will affect the time, place and manner in which Ohioans exercise their right to vote. LWV Ohio has three major concerns with the legislation. It eliminates poll-workers' responsibility to assist voters seeking the correct precinct; it reduces options for absentee voting; and it decreases recognition of voter intent.

The Ohio House passed House Bill 194 (HB 194, Mecklenborg, R-Cincinnati/Blessing, R-Cincinnati) May 18<sup>th</sup>. A competing bill containing Secretary of State Husted's proposed changes, Senate Bill 148 (SB 148, Wagoner, R-Toledo), was passed by the Senate May 24<sup>th</sup>. It is anticipated that the Ohio House and Senate will soon (possibly next week) resolve their differences on the two bills.

### **\*\*NEW\*\* Local Leagues Talk Redistricting**

On May 24, LWV Oxford hosted a redistricting workshop featuring Ann Henkener, LWV-Ohio Redistricting Specialist. This month, LWV-Ohio will be sending out information on the statewide redistricting competition that will take place over the summer.

The competition and the accompanying educational outreach will 1) educate Ohioans about the serious implications of Ohio's hyper-partisan redistricting process, 2) build consensus around specific redistricting reform measures, and 3) build a base for future reform of redistricting standards for Ohio House and Senate and congressional districts. Ohioans will be invited to draw district lines using 2010 Census data parallel to the Ohio Apportionment Board's and General Assembly's redistricting processes for a "real-world, real-time" experience. The competition will also draw increased attention to the need for reform because the public will be able to compare the objective results of the competition with the results of the partisan redistricting processes. ### **\*\*REMINDER\*\* Deadline to Transfer Local League Education Funds: June 30, 2011**

We are in the fourth quarter of our fiscal year and following up on earlier notes; the LWV-Ohio Education Fund will discontinue administering local League education funds (LLEFs) at the end of this fiscal year—June 30, 2011—rather than start charging fees of participating Leagues.

**To continue to ensure the local Leagues' ability to easily maintain their education funds**, the board has investigated and shared a number of options for transferring administration of your League's education fund to another entity with the presidents and treasurers of the local Leagues. **The LLEFs currently administered by the state Education Fund must be transferred from the LWV-Ohio Education Fund before the June 30, 2011, deadline.**
