## **\*\*NEW\*\* 2011 Legislative Interview Materials Now Available —Building Relationship with Your Legislators!!**

**What:** LWVO highly encourages local Leagues to conduct face-to-face interviews with their Ohio legislators at the beginning of each new session of the General Assembly (odd-numbered years).

**Why:** There are two reasons for the interviews.

- They allow local Leagues to establish relationships with newly elected officials and solidify connections with returning legislators in an easy way.
- Second, it is essential that the League build relationships with legislators and promote our advocacy agenda—and local Leagues get first chance at establishing that relationship.

**When:** Interview by May 1, 2011. Return information to LWVO by May 15, 2011.

**What if my League can't interview our assigned legislator(s)?** In that case, **it is important you let LWVO (and any other Leagues who share the legislator) know by February 28, 2011.** If another League does not volunteer to fill in, LWVO will interview key legislators that have not been interviewed.

**Where is the information Leagues need?** The Legislative Interview Packet is on the LWVO website in the Member Login section under [2011 legislative interview materials](#). The packet includes local League assignments, suggestions and the interview questions and reporting form.

**\*\*Reminder\*\* With the New Year, It's Time to Update Your Membership Roster! – From LWVUS**

It's that time of year again: please update your membership roster with LWVUS for an accurate member count! The member count (determined by your updates to the LWVUS membership database) will “freeze” on January 31, 2011. This number will determine the amount your League must pay in PMP for FY2011-12. To update your member count, you must update your roster, including the expiration date and status (“inactive” or “active”) in each member record. **\*\*NEW\*\* Deadline to Transfer Local League Education Funds Is Fast Approaching**

We are at a mid-point in our fiscal year and following up on earlier notes we wanted to remind local Leagues with education funds that the LWV-Ohio Education Fund will discontinue administration of local League education funds (LLEFs) at the end of this fiscal year—June 30, 2011—rather than start charging fees of participating Leagues.

**To continue to ensure the LLEFs' ability to easily maintain its education funds, we are committed to ensuring a smooth transition of fund oversight to a program that will continue to provide your League with effective, timely and no-charge administration of your League's education fund.**

To that end, the board investigated a number of options for transferring administration of your League's education fund to another entity and has shared those options with the presidents and treasurers of the Local Leagues that have their LLEF with the State Education Fund.

The option we recommend is that those LLEFs move their funds to a similar program run by the national League (LWVEF). The LWVEF is the administrator of nearly half the local Leagues' education funds in the country. Their system is provided at no cost and is efficient!

- The LWVUS website has the form and procedure to be used to transfer your League's account.
- LWV-Ohio EF could do it for you, but this requires your League's written consent.

Leagues also have the option to establish their own education fund, as some local Leagues have done. However, it is then the responsibility of your local League to comply with all IRS and state filing requirements.

**The LLEFs currently administered by the state Education Fund, may transfer its fund from LWV-Ohio Education Fund any time before the deadline of June 30, 2011.**

**Please know that we are committed to providing assistance to your League to make this transfer successful.**
